New Partnership with University Administration

During the past summer, the Executive Committee submitted a proposal for partial funding of the ERA budget by the University to help support outreach to members, and to establish a physical presence on campus. In his response to the Committee, President Jimenez-Sandoval stated, "I'm happily approving this request..." thereby inaugurating a new partnership with ERA.

In the past, our revenue has come from a single and modest source—dues rebates from ERFSA. That is, for each of our dues-paying members, we receive a small percentage of his/her dues paid to ERFSA. Those monies have just barely been sufficient to provide for newsletter expenses and 2 luncheons per year. Shortfalls between rebate income and expenses have been covered by a cushion of funds from past years of inactivity. But cushioning funds eventually will run out, especially considering rising catering costs and expenses to upgrade the preparation and presentation of our biannual newsletter.

The following will be made possible through this university partnership: modest funding to complement ERA's income from dues rebates; an online presence; event space and coordination; and, physical office space on campus. This means office space for producing newsletters and promotional materials, a campus 'home' for emeriti and retirees when visiting campus, as well as meeting space for Executive Committee meetings. This new partnership will be acknowledged in ERA materials, at luncheons, and on the ERA webpage to promote volunteer and donation opportunities to our members.

As this newsletter 'goes to press,' the details of finding available space on campus are still being worked out. Your ERA leadership is deeply gratified for being welcomed and recognized as a vital partner contributing to the future of Fresno State.

Benefits of EFRSA

The Emeritus and Retired Faculty and Staff Association (EFRSA) was established in 1985. Until 2018 it was known as the Emeritus and Retired Faculty Association. In that year the association voted to change its name to include retired CSU staff.

The first task of the organization was to bring local campus organizations in as affiliates of the state group. The "carrot" offered was a 15% rebate of the dues paid by local group members. Eventually all existing locals bought into this plan. The Fresno campus did not have a local organization until 1995. Under the leadership of Prof. Lester Roth, a local organization was established and immediately joined the state organization as an affiliate.

ERFSA is recognized by the CSU Board of Trustees as the official voice of retired faculty and staff. In order to interface with organizations that have like interests, the ERFSA State Council chooses a voting representative to serve on the statewide Academic Senate and liaisons to the California Faculty Association (CFA), the Retired Public Employees Association (RPEA), and the Statewide Coalition of Retired Employees (SCORE).

ERFSA provides a number of important member services. Three will be highlighted here.

First, on a "global" level, the organization works diligently to represent the interests of its members at the state and national levels. Its major focus is to protect and enhance our pension and health benefits. Through the efforts of its professional staff and many dedicated volunteers, ERFSA tracks proposed legislation as it makes its way through the State Legislature and the halls of Congress. At the state level, our representatives meet with individual legislators, legislative committees, and executive branch representatives to ensure that our voice is heard on matters that concern us as retirees. In addition, meetings are held regularly with staff and managers of CaIPERS and other state agencies when regulatory changes are under consideration.

The second major benefit is a personal one. If you experience difficulties, particularly with your pension or health care benefits, help is but a phone call away. You can call the ERFSA office at 1-818-677-6522 to either get help or be directed to someone who has expertise in dealing with your particular issue. Another good source of help is the ERFSA website: www.csuerfsa.org. Among other resources are back issues of The Reporter which may have articles of interest to you.

Finally, ERFSA has a grants program which funds research and creative activities undertaken by our members. A complete description of the program including information on how to apply is on the website.

ERFSA has proven to be a major force as an advocate for CSU retirees. I expect it will continue to be in the foreseeable future.

Out of high school, I moved 200 miles away from home to attend a small, liberal-arts college on the eastern edge of Los Angeles County. What an abrupt awakening from having grown up on a small farm in Atwater! I returned to the Valley to teach at the age of 23. During 14 years in grades 7-12, I earned a Masters Degree from Fresno State, then decided to go into teacher preparation at the university level. To do that, I took sabbaticals, personal necessity days, and unpaid leaves to attend University of the Pacific, earning a doctorate in 1988.

After four decades in education—public school teaching and teacher training at CSU Fresno—I retired to return to my creative writing roots. A new world of endeavor means becoming a learner yet again. For several years I've studied with an established, nationally recognized poet from Santa Cruz. In my academic life, I had conducted research and had articles published in refereed journals. But, in creative writing, work is submitted to contests (rather than committees or editors)! In my new life as poet, I've had a first chapbook published (2017); several poems have received awards, the highest being the James Miller (Grand Prize) Award given by the oldest poetry society in California, the Ina Coolbrith Circle.

I joined ERFSA/ERA for connection to that prior life of mine (academia). Through staying in touch with colleagues, I find opportunities to give back to the milieu which enabled me to thrive and prepare for a second life as artist—a term I continue to find surprising in reference to myself.

Transitioning into retirement and joining EFRSA and the local ERA chapter has been an opportunity to stay connected with the university. It is a pathway to re-examine, reinvent and reimagine time in continual learning and personal growth with colleagues. I have also spent time with family, friends and enjoy reading, writing, gardening, painting and volunteering with various organizations. In the past two years what I missed most is my love of travel.

My Fresno State adventure began in 1983 when I enrolled as a 37-year-old transfer student, a simple event that somehow evolved into a 35-year career. That convoluted path led from student, to staff, to lecturer, to tenure, to department chair, to retirement and then finally back to part-time adjunct. In the old days at Disneyland, it would've been considered an "E Ticket" ride.

Always the media guy, I taught most of the video and audio production classes in what's now known as the

Media Communications & Journalism Department. I was also very active with the campus radio station, KFSR, and served in every position from on-air volunteer to station manager. I also did a stint as the first online advisor for the Collegian and came back after retirement to teach photojournalism.

Along the way I became involved with the CSU Summer Arts program and followed the same sort of circuitous path, going from student, to staff, to course coordinator in the 20-plus years I worked for them.

I retired in December 2011 as endowed Professor and Chair Emeritus. Since retiring I helped launch the Community Media Access Collaborative (CMAC) and currently serve as Board Chair of the Valley Music Hall of Fame.

I came to Fresno State in 1970 on a one-year appointment to replace a faculty member who resigned in August. I was given a tenure-track appointment the next year. My service during the 1970's included Chair of the Speech Communications Department, membership in the Academic Senate and service on the Executive Committee, and as an active participant in the formation of CFA. Beginning in 1981, I served for 12 years in several capacities in the central administration. The rest of the decade of the 1990's was spent teaching in my

department. I retired in 2000 and taught in the FERP for three years.

I joined ERFA (now ERFSA) in 2001 primarily because I was impressed by the work the organization was doing in advocating on behalf of CSU retirees, especially in the areas of health benefits, policy formation and legislation.

I became Fresno's representative to ERFA's State Council in 2006. I continue to serve in that capacity as well as President of ERFSA's Charitable Foundation. In 2009, I was asked to pursue the revitalization of our chapter. Four colleagues agreed to work with me on this. We launched the revitalized chapter in 2011. The activities of our local group have continued to expand. We now have a significant presence on the campus and are doing good work on behalf of our membership.

I am a native of New Orleans. Louisiana. I hold Bachelor's degrees in Business Administration and the MBA from Fresno State, and the Doctor of Education degree from the University of Southern California. I was a full professor at Fresno State and taught courses from 1972 until 2007 in Africana Studies and in the School of Business (Management and Marketing). I served twelve years (1978-90) as the Chairperson of the Ethnic Studies Program. In 2007, was bestowed the honor of Professor Emeritus of Africana Studies

I am the founder of the Africana Studies Research Center and served as Director. I co-chaired the Martin Luther King, Jr., Monument Committee, which commissioned the life-size statue of Dr. King located in the University's Peace Garden. Currently, I am serving on the President's Nelson Mandela Project Monument Committee.

I received a FIFSE grant of \$243,000, and published works including Black Town, Allensworth, and a manuscript entitled, "Peter Davis: The First Music Master of the Great Louis Armstrong." I have several entries on the academic website, blackpast.org. I served as an elected official at Educational Employees Credit Union. Currently, I volunteer as Jazz Host at KFSR 90.7, FM, Red Beans and Jazz, Fridays, 9:00am to 12:00pm.

I received my undergraduate training at UCSB and did graduate work at San Francisco State and USC. Music Professors Honored

Two retired professors from the Fresno State Music Department were honored with induction into the inaugural class of the Valley Music Hall of Fame.

Russel Howland taught music at Fresno State for 27 years and was a multi-instrumentalist in the Fresno Philharmonic Orchestra. He was also a brilliant conductor, composer and arraigner, who created and composed music for the clarinet choir, woodwind choir and saxophone quar-



ter. He also led many school honor-bands and orchestras and taught workshops nation-wide. He was one of the most highly regarded woodwind teachers in the US at that time. He was loved by his students and many credit him with inspiring their careers. He received the Distinguished Professor Award in 1973 and retired in 1975.

Dr. James Winter starting teaching music at Fresno State in 1947 and played in the Fresno. Philharmonic

Orchestra for 40 years. He was a gifted and dedicated teacher and highly respected by the horn and brass playing community. From 1948-68 he taught all the brass courses at the university, to the point that the entire brass section of the Fresno Philharmonic was



made up of his students. In the early 1970's he assembled the President's Quintet and guided them through tours of Europe and Asia, where they won competitions against major music schools. He retired in 1987.
